Monthly Town Board Meeting

Wednesday, March 11, 2020

Chairperson Dennis Bergeson called the monthly meeting to order at 6:00 PM with 23 in attendance.

Don Limberg made a motion to accept the agenda as listed. Audrey Guseck seconded the motion. Roll Call: Audrey Guseck – yes, Don Limberg – yes, Dennis Bergeson - yes. Agenda approved.

Audrey Guseck made a motion to accept the minutes as read. Don Limberg seconded the motion. Roll Call: Audrey Guseck – yes, Don Limberg – yes, Dennis Bergeson – yes. Minutes approved.

Wendell Philipps gave the treasurer’s report noting the total cash on hand as of February 28, 2020, was \$384,479.40. Don Limberg made a motion to approve the treasure’s report as read. During Open Floor there was discussion on the pot holes on Bagley Road. A discussion was held on the deterioration of Jacobsen and Schroeder Roads. There was also discussion on PFAS and the testing of wells. A town resident inquired about the timeline for construction on the end of Bagley Road. Thanks went out for cutting the Oak tree down on Bagley roadside. Laura Frea, County Board representative for Dist. 14, gave a talk about herself for the upcoming election. Laura’s number is 715-732-4321 if you have any questions. An inquiry was made to see if the town had any record showing names for the burial sites at the Winesville Cemetery.

There were 160 voters that came out to the February 18th Primary Election. The next election is April 7, 2020.

The 2020 Census mailings go out between March 12 and March 20, 2020.

Recycling Center – There was discussion on the cover over the trash compactor as it is leaking and needing to be replaced. There was discussion about the Town purchasing a small front-end loader and getting rid of the skid steer.

Animal Control – Carl had 2 calls over the past couple months.

Building Permits – nothing at this time.

Correspondence was read and bills were paid.
