MONTHLY TOWN BOARD MEETING

June 14, 2023

Chairperson, Dennis Bergeson called the monthly board meeting to order at 6:00 PM with 15 in attendance.

The Pledge of Allegiance was recited.

Don Limberg made a motion to approve the agenda as printed. Audrey Guseck seconded the motion. Roll Call: Audrey Guseck – yes, Don Limberg – yes, Dennis Bergeson – yes. Agenda approved.

The following have been graveled and pulverized: Jacobsen, Philipps, and Schwalla which will remain graveled until funding is available.

Dumptruck is in for repairs.
